Proposition 1 Grant Program Approved Projects and Current Solicitation Updates

Staff Report

CURRENT SOLICITATION UPDATE

The Delta Conservancy received five full proposals for the 2016-2017 fiscal year solicitation of the Ecosystem Restoration and Water Quality Grant Program (Grant Program). In total, applicants requested \$6.4 million. Staff recommends that the Board conditionally approve or reserve funding for four proposals that, in total, have requested approximately \$4.4 million.

APPROVED PROJECT UPDATE

For the 2015-2016 grant cycle, the Board awarded or reserved funding for eight projects with a total funding request of \$5.9 million. To date, three grant agreements have been fully executed, one is being routed for signature, three are being drafted, and one is finishing the CEQA process. A brief update on each project is provided below:

Project: Lower Marsh and Sand Creek Watershed Riparian Restoration Planning Project

Amount Awarded: \$73,493

Conservancy ID: Prop 1-Y1-2015-019

Grantee: American Rivers

Overview: Improve restoration project efficiency within the Marsh/Sand Creek watershed through development of a programmatic CEQA document and permit, including stormwater planning.

Board Action/Deadline: Approved

Conditions/Status: None

Grant Agreement Status: Active as of 10/19/16

Update: In January of 2017, the grantee submitted their first quarterly report and invoice. The grantee met with various partners to begin planning the programmatic CEQA document for the Marsh and Sand Creek watersheds and began discussions about stormwater treatment design and revision of Contra Costa County's Stormwater 3C Handbook.

Project: Fish Friendly Farming Certification Program for the Sacramento-San Joaquin Delta (Planning)

Overview: Develop a program for working with farmers to improve water quality, which is specific to

The tracking sheet included in this agenda item lists all of the 2015-2016 projects for which the Board approved, conditionally approved, or reserved funding. Each of the eight projects has an assigned grant project manager. Grant project managers work with grantees to gather all of the required information needed prior to drafting a grant agreement, and they draft the scope of work and budget for the grant agreement. The Conservancy's administrative team assembles the complete grant agreement and routes it for execution. Complete grant agreements are sent first to the Conservancy's legal counsel for review, then to the grantee for signature, and finally to the Conservancy's Executive Officer for execution.

BACKGROUND

The Conservancy's Proposition 1 Ecosystem Restoration and Water Quality Grant Program is focused on restoring and enhancing Delta ecosystems, improving water quality, and enhancing water-related agricultural sustainability. The Grant Program identifies projects to protect and restore California rivers, lakes, streams, and watersheds that may be funded with Proposition 1 funding (Sec. 79732 et seq). The Conservancy anticipates administering at least one grant cycle each fiscal year between 2015 and 2020. The Grant Program is a competitive, two-step process, requiring both a concept proposal and a full proposal. Full proposals are subject to a rigorous scoring and evaluation process by both staff and an external review panel, and are recommended based upon score and funding availability.

BUDGET

Proposition 1 identified \$50 million for the Delta Conservancy "for competitive grants for multibenefit ecosystem and watershed protection and restoration projects in accordance with statewide priorities" (Sec. 79730 and 79731). For the 2015-2016 fiscal year, \$9.3 million was allocated to the Conservancy for the Ecosystem Restoration and Water Quality grant program. For the 2016-2017 fiscal year, \$10 million is available for the grant program.
