Agenda Item 2 – Welcome, Roll Call, and Introductions

Agenda Item 3 – Public Comment

Martha Ash sent an email inquiry with two questions:

- 1. Where is the meeting agenda physically posted? The agenda is only posted on the website.
- 2. When was the agenda posted and what are the requirements of the Bagley-Keene Open Meetings Act (Bagley-Keene) and are there any exceptions to Bagley-Keene due to COVID -19? Agenda Item 4 - Consent Calendar

Agenda Item 5 – Executive Officer's Report

The Executive Officer introduced two newly-hired staff members: Chelle Temple-King, Environmental Scientist; and Martha Ozonoff, Associate Government Program Analyst. The Conservancy, in conjunction with the Delta Protection Commission, continues efforts to post "Welcome to the Delta" signs despite recently denied encroachment permits. Board members suggested possible options that will be pursued. There were no Board directives from the March meeting. Staff presented the Budget and Expenditure Report and additional items for year-end expenditures were reviewed.

Agenda Item 6 - Proposition 1 Program Update

Staff presented highlights from the Proposition 1 Program Update Staff Report.

Proposed Cycle 5: No changes from the March Board meeting.

Cycle 4: Two grant agreements have been executed and Prop 1-1813 Nutria Eradication Project, Phase 2, is ready for signatures.

Cycle 3: All of the grant agreements have been executed and are moving forward.

Cycle 2: The Dutch Slough Revegetation Project has planted 260 acres, approximately 50% of the project area.

Cycle 1: Three projects have closed and one more is almost complete. The construction contract has been executed for the Three Creeks Parkway Restoration Project and a groundbreaking ceremony is scheduled for June 25, 2020.

Agenda Item 7 – Proposition 68 Program Update

Staff presented highlights from the Proposition 68 Program Update Staff Report. The Conservancy has received eight concept proposals to date, one of which is ineligible. Staff is working with four applicants to assess viability and three applicants to develop full proposals. There was an inquiry concerning how long proposals will be accepted into the program. Staff responded that there is no stated end date and the program will continue as funding permits.

Agenda Item 8 – Delta Mercury Exposure Reduction Program Final Update

Staff delivered a slide presentation of the Delta Mercury Exposure Reduction Program (MERP). The primary goal of the six-year program, funded by the State Water Resources Control Board, was to protect public health by reducing the risk of exposure to methylmercury from eating fish from the Delta. Since 2014, MERP worked with program participants in a small grants program with more than 50 staff and volunteers. MERP focused on community outreach through social media, events, presentations, and trainings. During the program, 147 advisory signs were posted at highly-visible areas, with 90% of the signs place in or near disadvantaged communities. Funding for the program ends in June 2020. Board members expressed their gratitude for the work of the Conservancy staff.

Agenda Item 9 - Delta Stewardship Council Update

Amanda Bohl, Special Assistant for Planning and Science for the Delta Stewardship Council (Council), provided an update. The Council will hold a virtual public hearing on July 6, 2020 on the Lower Yolo Ranch Restoration Project appeal. The Council continues its multi-year work on the amendment to Chapter 4 of the Delta Plan. Most recently, the Council has initiated the California Environmental Quality Act process for the amendment. On June 3, 2020 the Council will host part two of a four-part virtual discussion series on how to build an effective Delta science enterprise. Eva Bush, Senior Environmental Scientist, reported on the Delta Science Action Agenda (DSAA), which is one of the three guiding documents of the Delta Science Strategy, and is updated every five years. The Council is working on the 2022 to 2026 update. Outreach to receive input from the science community and Delta stakeholders is underway. The Council anticipates the release of a draft DSAA in the fall of 2020. More information on these updates can be found on the Council website.

Agenda Item 10 – Delta Protection Commission

Erik Vink, Executive Director of the Delta Protection Commission (Commission), presented a brief update. Work continues on the National Heritage Area initial planning effort and on the update of the Economic Sustainability Plan recreation and tourism chapters.

Agenda Item 11 – Delta Conveyance Update

Carrie Buckman, Environmental Program Manager with the Department of Water Resources (DWR), presented an update. DWR just finished the public scoping process and is reviewing comments from eight public meetings, and 850 comment letters which included more than 3,500 individual comments. They are working on the draft Environmental Impact Report and anticipate completing it in early 2021. The Delta Conveyance Design and Construction Authority meetings continue and provide a venue to share technical information with the Delta community. DWR is considering a number of soil investigations for 2020. Some of the court-ordered soil explorations in Sacramento and San Joaquin County are scheduled to be completed in the fall of 2020. Other soil explorations on public lands are being considered once permits are obtained. Finally, DWR plans to start talking to private landowners about soil explorations for 2021.

Agenda Item 12 – EcoRestore

Charlotte Biggs, Program Manager II at DWR, provided an update on the EcoRestore initiative. The EcoRestore initiative is celebrating their five-year anniversary and has produced an eight-page expanded fact sheet highlighting the accomplishments of the program partners. The fact sheet will be available soon on the EcoRestore website.

Chair Mitchoff had to leave the meeting at this point and turned the meeting over to Vice Chair Winternitz.

- 3. Martha Ash, a member of the public, asked if there have been reports of nutria in the Franks Tract State Recreation Area (Franks Tract). The Executive Officer responded that a single nutria was detected near Rough and Ready Island outside of Stockton about six months ago. There have been no further sightings in the Delta.
- 4. Martha Ash asked if Franks Tract will be filled with tunnel boring material, and if so, when? The Executive Officer briefly described the ongoing Franks Tract planning effort being conducted by the California Department of Fish and Wildlife and directed Ms. Ash to their website for additional information.

EXECUTIVE OFFICER'S REPORT July 22, 2020

PROGRAM UPDATE

STAFFING UPDATE

Sadly, we must say goodbye to Laura Jensen who has accepted a position as the Assistant Executive Officer of the California Water Commission. Laura has been with the Conservancy for five years and was the lead for the development of the Proposition 1 and Proposition 68 grant programs. Laura's hard work, dedication, and exceptional organizational skills were critical to the success of these programs and we thank her for all her hard work. This is a great opportunity for Laura; please join me in wishing her the best.

Please welcome Dr. Rachel Wigginton, our newly-hired Senior Environmental Scientist. Rachel will be applying her scientific expertise to the Conservancy's various projects and representing the Conservancy within the Delta science community. Rachel came to California from Kentucky ten years ago to pursue graduate research in wetland ecology and conservation management. Before coming to the Conservancy, Rachel was with the San Francisco Bay Conservation and Development Commission, leading the agency's effort to review and update its Suisun Marsh Protection Plan and Local Protection Program. Rachel started with the Conservancy on July 6th.

HAPPY 10TH ANNIVERSARY TO THE DELTA CONSERVANCY

This year marks the 10th anniversary of the Sacramento-San Joaquin Delta Conservancy. The Delta Conservancy was created as part of the Delta Reform Act passed in late 2009, and in March of 2010, the Delta Conservancy Board met for the first time. We have accomplished so much since that first Board meeting as the Conservancy has evolved and grown into our role as a state partner for ecosystem restoration and economic development in the Delta and Suisun Marsh.

Significant funding for the Conservancy arrived with the passage of Proposition 1 in late 2014. Staff went to work developing and implementing our Ecosystem Restoration and Water Quality grant program, that to date has resulted in 29 community-supported projects enhancing over 8,000 acres in the Delta. With the more recent passage of Proposition 68, the Conservancy has developed our Community and Economic Enhancement grant program that will fund projects that support the economic vitality of the Delta and serve its disadvantaged communities. In addition to these grant programs, the Conservancy has led and supported many important collaborative planning and outreach efforts. We have also been a driving force for the development of market-based incentives to address subsidence and related carbon emissions. The Conservancy was honored when the American Carbon Registry presented the 2017 Innovation Award to the developers of this landmark methodology for California wetland restoration.

The Delta Conservancy has maximized the funding and resources available to us, and our staff and Board have realized the intent of our enabling legislation and become a trusted and effective partner. The Conservancy has clearly demonstrated the value of a state partnership and what can be accomplished in the Delta when we work together.

I would like to personally thank all past and current Board members and Ex-Officio Legislative members for their guidance and contributions to our achievements. And to past staff, many of whom have gone on to significant leadership roles, and our current team of bright and dedicated public servants; thank you for all your hard work and for making the Conservancy a great organization.

Our stage is set for a bright future as we continue to engage the Delta community. What comes next for the Delta Conservancy will depend largely on available funding, there is no limit to what we can do if resourced to do it! Happy 10th Anniversary, Delta Conservancy!! Here's to many more.

COVID-19 UPDATE

All Conservancy staff continue to work from home with the expectation that this will continue until a vaccine is approved. Staff have done an excellent job adapting to our new reality and continue to be very productive with only minor disruptions in our workflow. We are currently developing procedures to ensure upcoming project site visits can be conducted safely and with appropriate social distancing. Larry Hughes has volunteered to be our designated Contact Tracer. He recently completed his weeklong training and will likely be called upon in the coming weeks for a six-month deployment.

CONTRACTS

The Conservancy is in the process of amending the technical support contract for our Delta carbon and subsidence work. The amendment will increase the budget by \$80,000.00 and add two additional pilot projects to the scope of work. The original agreement supported project development and third party validation/verification of carbon offsets for the three Department of Water Resources managed wetlands projects on Sherman and Twitchell islands. The amendment will support similar activities, including project development, carbon flux estimations, monitoring program development, and third-party validation/verification for two additional pilot projects. Staff are currently working closely with two land owners, one of whom is interested in converting over 1,000 acres to rice cultivation and the other interested in engaging the carbon market for an existing, recently converted, rice project of several hundred acres and a future managed wetland project of approximately 1,000 acres. The contract amendment is awaiting final approval by the Department of General Services and should be executed within the next several weeks.

ECOSYSTEM RESTORATION PROGRAM

Nutria Eradication:

Delta Subsidence and Carbon Emissions:

The Conservancy continues to work to develop pilot projects and support land owners in their efforts to explore carbon market opportunities. A Delta Carbon overview and update will be provided as Item 10 on the agenda for this meeting.

Water Resilience Portfolio:

Governor's Executive Order Number N-10-19 calls for the development of a Water Resilience Portfolio to guide the Administration's water policy. A draft of the Portfolio was released in January. The release of the final Portfolio had been delayed due to the COVID-19 restrictions.

COMMUNITY AND ECONOMIC ENHANCEMENT PROGRAM Delta Marketing:

Through an interagency agreement, staff have been working with the Delta Protection Commission (Commission) to implement elements of the Five-Year Delta Marketing Plan and the Delta Sign Plan, which was a recommendation in the Marketing Plan. Together, Conservancy and Commission staff submitted 11 encroachment permit applications to Caltrans for "Welcome to the Delta" signs throughout the Delta. Unfortunately, the encroachment permits have been denied. Staff met with representatives from Assemblymember Grayson's office to discuss ways that the Legislature might support the plan and help staff get the signs posted. Conservancy staff and Assemblymember Grayson's office continue to coordinate with Caltrans.

The Delta Marketing Plan also recommended creation of a Delta recreation map and in November the Commission printed 6,500 maps. A distribution plan has been developed and staff is reaching out to contacts on the distribution list, but many are still closed due to COVID-19 restrictions.

Nutria Eradication Program Update

Field Update

Since implementing the Nutria Eradication Incident Command System (ICS) in March 2018, the California Department of Fish and Wildlife, along with three USDA-Wildlife Services contracted trappers, U.S. Fish and Wildlife Service refuge staff, and the California Department of Food and Agriculture's delimitation crews, have:

- Completed full and/or rapid assessments on over 843 K acres
- Executed entry permits with over 2500 landowners
- Set up 2,297 camera stations (628 currently active)
 - Conducted 12,585 camera checks
- Confirmed nutria within 329 sites
- Deployed 3,332 trap sets for a total of 38,599 trap nights
- Taken or accounted for the take of 1,402 nutria (since Mar 2017)
 - o Merced- 1,058
 - o Stanislaus- 229
 - San Joaquin- 101 (100 from Walthall Slough)
 - o Mariposa- 12
 - o Fresno- 2
- Of 1,125 necropsies, the data has shown:
 - 1.17 sex ratio (M:F)
 - Of the females captured:
 - 26% of juvenile (2-6 mos.) females have been pregnant
 - 60% of subadult (6-14 mos.) females have been pregnant
 - 71% of adult (>14 months of age) females have been pregnant
 - 1313 fetal nutria have been documented
 - Litter size ranged from 2-13, with an average of 6.0
 - Average litter size for adult females (> 14 mos.) in California is 6.6

Approved Project Update

To date, the Conservancy has approved a total of 29 projects, committing approximately \$39.3 million for Proposition 1 projects. A brief overview of each grant cycle, including the status of each funded project for which there is an active or pending grant agreement, is provided herein.

Cycle 4 - Fiscal Year 2018-2019

The Board awarded approximately \$14.9 million for ten projects (eight planning and two implementation). Three grant agreements have been executed; staff is working with grantees to negotiate seven grant agreements.

PROGRAM UPDATE

The Proposition 68 Community and Economic Enhancement Grant Program is designed to promote a robust Delta economy, support the vitality of Delta communities, and allow staff to partner with project proponents to develop proposals that meet these goals. The Conservancy has received eleven concept proposals to date. One was deemed ineligible under General Obligation Bond law, and one was determined not to be a viable project. Staff is currently working with four applicants to assess the viability of proposed projects and five applicants to develop full proposals.

Staff will continue to evaluate opportunities for outreach and collaborate to develop projects as appropriate.

BACKGROUND

Proposition 68 is the California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor Access for All Act of 2018 (Public Resources Code (PRC), Division 45) that was passed by California voters on June 5, 2018. Proposition 68 makes \$12,000,000 available to the Conservancy to use for the purposes specified in its governing statute (Sacramento-San Joaquin Delta Conservancy Act, Public Resources Codes, Division 22.3). The Conservancy's Proposition 68 funds will be used to fund projects in the Conservancy's Community and Economic Enhancement Grant Program to support community and economic development in the Delta in a manner that is complementary to ecosystem restoration and other Conservancy programs. Delta Conservancy 2020 Implementation Plan Status Update **Staff Report**

This item presents the Sacramento-San Joaquin Delta Conservancy's (Conservancy) progress toward meeting the goals of the 2020 Implementation Plan.




Subsidence and Risks

- Sea levels are rising at a rate of about 0.3 inch per year






Subsidence Process





Delta Public Lands Strategy

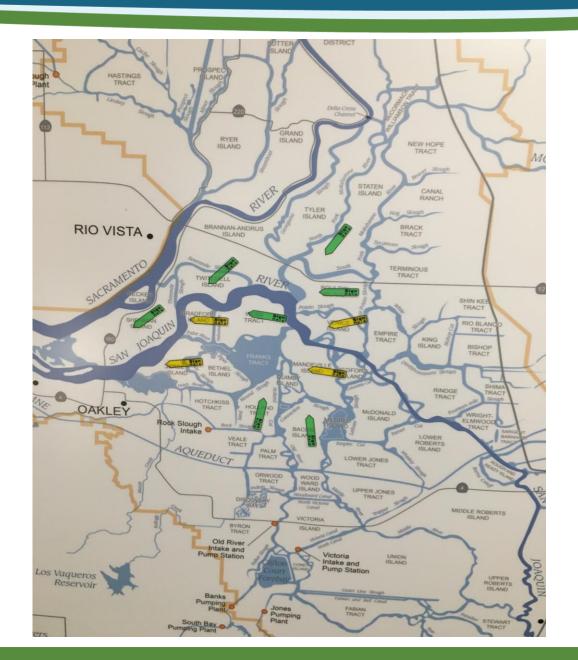

Greenhouse Gas Emissions Reductions

- ACR Methodology approved in April 2017 First 3rd party validation/verification in progress for 1,600 acres of wetland
- Working with public and private land owners to develop pilot projects
- Working with carbon financiers and investors to market resulting carbon credits
- Seeking funds to support project construction
- Ongoing discussions with ARB for eventual inclusion in the compliance program


