Agenda Item 6 – Executive Officer's Report

The Executive Officer thanked and said goodbye to Laura Jensen, Program Manager, and introduced newly-hired staff member Dr. Rachel Wigginton, Senior Environmental Scientist. The Executive Officer recognized the Conservancy's ten-year anniversary with a brief history of the organization. The Conservancy continues its COVID-19 practices with all staff teleworking, and has contributed to the relief effort by supplying Larry Hughes as a Contact Tracer. Our contract work continues as we augment the Delta carbon subsidence contract to incorporate two pilot projects into the work. We continue attending monthly meetings with the California Department of Fish and Wildlife regarding the nutria project, and the June update is included in this meeting's Board packet. The most current count of nutria taken is 1,816. The Executive Officer provided the latest update on our efforts to post Welcome to the Delta signs; staff is working with Caltrans on alternatives. The Board directives and responses from the May 27, 2020 Board Meeting were addressed and there were no questions. Staff presented the fiscal year 2020-2021 Budget and Expenditure Report.

Agenda Item 7 - Proposition 1 Program Update

Staff presented highlights from the Proposition 1 Program Update Staff Report.

Cycle 4: Three grant agreements have been executed and four are in process. The Elk Slough Fish Passage and Flood Improvement project has started.

Cycle 3: Construction commenced at Three Creeks Parkway Restoration Project #2. Stone Lakes Restoration project design plans have been completed at a significant savings. The Restoration Planning at River Garden Farms project has some overlap with a Department of Water Resources (DWR) project, which staff is working with the grantee and DWR to address. The Board asked to stay informed of the activity.

Cycle 2: Restoration of Priority Wetlands for Endangered Species at the Cosumnes River Preserve is the first implementation project to close. Project staff has assumed the monitoring work since core volunteers are not available due to COVID-19.

Cycle 1: Fish Friendly Farming Certification Program for the Sacramento-San Joaquin Delta will soon be the fourth grant to close and move into the post-project monitoring phase. Three Creeks Parkway Restoration Project #1 started construction in June.

Agenda Item 8 – Proposition 68 Program Update

Staff presented highlights from the Proposition 68 Program Update Staff Report. The Conservancy has received ten eligible concept proposals, which is three more than the Conservancy had received as of the July 22, 2020 Board meeting. The ten eligible proposals have requested approximately 80 percent of the total grant funds. Staff will present recommendations to the Board as full proposals are completed, which may be as soon as the October 28, 2020 Board meeting.

This agenda item requests approval to extend the funding end date of the grant to accommodate project delays due to COVID-19 and wildfires.

RECOMMENDATION

Staff recommends that the Board approve amendment of the funding end date from August 31, 2021 to January 9, 2022.

DESCRIPTION

Impacts from COVID-19, poor air quality due to wildfires, and other issues have delayed the project. The grantee has requested approximately four additional months to complete all tasks in the scope of work for the grant. Conservancy staff have determined the request to be reasonable given the circumstances and one which the Conservancy can administratively accommodate.

In parallel to the requested extension of the funding end date and in accordance with policy established by the Board, staff has approved the removal of the USDA-Wildlife Service as a subcontractor on this project. The \$600,000 budget for that subcontractor has been reallocated to Personnel Services to allow the grantee to accomplish the same goals. The associated indirect costs have also been reallocated.

If the funding term is not extended, the grantee will not be able to complete the full extent of the surveying effort and trapping efforts, which are crucial to the effort to eradicate nutria from California.

BACKGROUND

In April of 2018, as part of the Cycle 3 of the Proposition 1 Ecosystem Restoration and Water Quality Grant Program, the Board approved the award of grant funds for the Nutria Eradication Project. The objective of this implementation project is to eradicate invasive nutria from California. The main goals of this multi-benefit project are to identify the locations of nutria infestations, reduce nutria populations state-wide to zero or near-zero level, and conduct long-term monitoring to ensure that new populations do not arise. This is the first amendment requested for this project.

This agenda item requests approval to extend the funding end date which will allow the grantee to further progress on the project beyond that which was originally thought possible and fully expend their grant funds.

RECOMMENDATION

Staff recommends that the Board approve amendment of the funding end date from March 31, 2021 to March 31, 2022.

DESCRIPTION

The grantee completed the designs specified in the scope of work for the grant and did so under budget. The grantee has requested to use the excess funds to produce additional design documents that move the project closer to being shovel ready. More time is needed to complete those additional designs. This request furthers a task that is already included in the original scope of work. Conservancy staff have determined furthering design documents to be an appropriate and efficient use of grant funds already awarded to the grantee.

In parallel to the requested extension of the funding end date and in accordance with policy established by the Board, staff has approved transfer of a total of \$41,000 from several cost categories to Personnel Services to pay salaries for staff to complete the additional design documents, should the Board approve the funding end date extension.

If the amendment is not approved, the grantee will have fulfilled the scope of work for the grant but will not be able to take advantage of funds that would otherwise be unexpended to advance the planning objectives of this grant. The unexpended funds would revert to the Conservancy and be available for future grant awards.

BACKGROUND

In April of 2018, as part of the Cycle 3 of the Proposition 1 Ecosystem Restoration and Water Quality Grant Program, the Board approved the award of grant funds to the Stone Lakes Restoration Project. The is a planning project which creates plans for the construction of a wide range of wetland types and plant associations that will support food web development. The main goals of the implementation phase of this multi-benefit project are to restore and create new wetland habitat, which is vital to the long-term success of several listed and endangered species as well as non-listed wetland dependent species. The outcome of the project for which this grant provides planning will be the restoration of approximately 257 acres of seasonal wetland, restoration of 39 acres of riparian seasonal wetland, and enhancement of 20 acres of existing low-quality wetland. This is the first amendment requested for this project.

EXECUTIVE OFFICER'S REPORT October 28, 2020

PROGRAM UPDATE

STAFFING UPDATE

Please welcome Dr. Sarah Lesmeister, our newly hired Environmental Program Manager. Sarah will oversee ecological and community programs such as Proposition 1 and Proposition 68 projects, supervise Conservancy staff, lead special projects, and formulate policies and procedures relevant to the Conservancy's mission. Sarah has worked in the Sacramento-San Joaquin Delta for 13 years, focused primarily on water quality, nutrients, pesticides and lower trophic organisms. Prior to coming to the Conservancy, Sarah was with the California Department of Water Resources as the Chief of the Environmental Monitoring Program and was an active member of the Inter-agency Ecological Program's Science Management Team. Sarah started with the Conservancy on October 12, 2020.

COVID-19 UPDATE

All Conservancy staff continue to work from home with the expectation that this will continue until a vaccine is approved. Staff have done an excellent job adapting to our new reality and continue to be very productive with only minor disruptions in our workflow. We are currently conducting virtual project site visits for both the Proposition 1 and 68 programs. Larry Hughes who volunteered to be our designated Contact Tracer, has officially been assigned to a six-month deployment.

JUSTICE, EQUITY, DIVERSITY AND INCLUSION (JEDI)

The Conservancy has formed a Justice, Equity, Diversity, and Inclusion (JEDI) Committee. The Committee is comprised of all staff and is co-chaired by two staff who will facilitate an on-going effort to increase staff knowledge and understanding of JEDI issues and explore how the Conservancy can improve its practices, both internally and externally. All staff have completed implicit bias training and participated in a subsequent discussion. Next steps will include development of a JEDI curriculum for in-house learning, as well as a series of brown bag lunches to provide staff an opportunity to discuss selected topics and learn from one another.

ECOSYSTEM RESTORATION PROGRAM

Nutria Eradication:

Please see the end of this report for the California Department of Fish and Wildlife's October 2020 update for the Nutria Program. Valerie Cook from California Department of Fish and Wildlife will provide an update for the program under Agenda Item 8.

Delta Subsidence and Carbon Emissions:

The Conservancy continues to develop pilot projects and support land owners in their efforts to explore carbon market opportunities. We are excited to announce that the California Air Resources Board (CARB) Offset Protocol Taskforce has recommended that CARB conduct additional review for

potential implementation of the American Carbon Registry protocol for Delta wetlands in to the AB 32 Compliance Offsets Program. This is significant because, if adopted, it would make carbon incentives equivalent to the value of the commodities currently grown in the deeply subsided regions of the Delta. Both the Administration's recently finalized Water Resilience Portfolio and the Governor's Executive Order N-82-20 setting a goal to conserve 30 percent of the State's land and coastal water by 2030, are strong drivers supporting the Conservancy's efforts to develop compelling economic incentives to address subsidence and carbon emissions in the Delta.

COMMUNITY AND ECONOMIC ENHANCEMENT PROGRAM Delta Marketing:

Through an interagency agreement, staff have been working with the Delta Protection Commission (Commission) to implement elements of the Five-Year Delta Marketing Plan and the Delta Sign Plan, which was a recommendation in the Marketing Plan. Obtaining the 11 encroachment permits for the "Welcome to the Delta" signs proposed in the Delta Sign Plan has been a challenge because this type of signage was not addressed anywhere in the California Manual on Uniform Traffic Control Devices (CA MUTCD). Staff from the Conservancy, Commission, and Caltrans met multiple times and determined the best route forward was to merge the "Welcome to the Delta" signs with National Heritage Area efforts, and request that the CA MUTCD to be amended to include signage for National Heritage Areas. The project team worked with Caltrans to create draft signs and will present this request to the California Traffic Control Devices Committee at their November 5, 2020 meeting.

DELTA SCIENCE

Conservancy staff continue to work collaboratively with the broader Delta science community to advance science in the region. On September 9, 2020, staff participated in the Science Needs Assessment Workshop organized by the Delta Stewardship Council. The workshop's aim was to refine a list of key Delta ecosystem management questions (more than 1,100 questions to start) and use this refined list to guide Delta science actions over the next five years. In contrast to this list of short-term science actions, the Science Needs Assessment Workshop, which staff attended on October 5 – 6, 2020, intended to forecast what the Delta Science Enterprise would need to support the co-equal goals in 20-50 years. The Science Needs Assessment was called for and organized by the Delta Independent Science Board, the Interagency Ecological Program, and the Delta Stewardship Council. Staff provided direct feedback in breakout groups focused on invasive species and science funding.

Conservancy staff are also contributing to the planning of the 2021 Adaptive Management Forum, an effort lead by the Delta Science Program. As part of the planning team, staff have provided input on the Forum's topics, speakers, and structure. The forum will take place in late January and has direct relevance to the adaptive management requirements we make of our grantees.

Conservancy staff facilitate the Delta Interagency Invasive Species Coordination (DIISC) Team, which had its third quarter meeting on October 8, 2020. During this meeting, all participating agencies and entities report on active invasive species management projects and activities. Conservancy staff, in coordination with DWR and Delta Stewardship Council staff, organized a panel discussion on Early Detection and Rapid Response to new invasive species.

Nutria Eradication Program Update

Field Update

Since March 2018, the nutria eradication efforts in California have:

- Completed full and/or rapid assessments on over 990 K acres
- Executed entry permits with over 3,300 landowners
- Set up 2,834 camera stations (>500 currently active as we initiate work in new management units)
 - o Conducted 18,813 camera checks
- Confirmed nutria within 413 sites
- Deployed 4,141 trap sets for a total of 51,691 trap nights
- Taken or accounted for the take of 1,816 nutria (since Mar 2017)
 - o Merced-1,189
 - o Stanislaus- 511
 - o San Joaquin- 102
 - o Mariposa- 12
 - o Fresno- 2

Of 1,769 necropsies, the data has shown:

- 1.17 sex ratio (M:F)
- Of the females captured:
 - 23% of juvenile (2-6 mos.) females have been pregnant
 - 60% of subadult (6-14 mos.) females have been pregnant
 - 69% of adult (>14 months of age) females have been pregnant
- o 1974 fetal nutria have been documented
- Litter size ranged from 1-13, with an average of 5.7
 - Average litter size for adult females (> 14 mos.) in California is 6.4

Proposition 68 Program Update Staff Report

PROGRAM UPDATE

The Proposition 68 Community and Economic Enhancement Grant Program is designed to promote a robust Delta economy, support the vitality of Delta communities, and allow staff to partner with project proponents to develop proposals that meet these goals. The Conservancy has received 11 concept proposals as of October 15, 2020. One was deemed ineligible under General Obligation Bond law, one was determined not to be a viable project, and one has been placed on hold at the request of the applicant. Staff is currently working with eight applicants to develop full proposals.

Staff will continue to evaluate opportunities for outreach and collaborate to develop projects as appropriate.


BACKGROUND

Proposition 68 is the California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor Access for All Act of 2018 (Public Resources Code (PRC), Division 45) that was passed by California voters on June 5, 2018. Proposition 68 makes \$12,000,000 available to the Conservancy to use for the purposes specified in its governing statute (Sacramento-San Joaquin Delta Conservancy Act, Public Resources Codes, Division 22.3). The Conservancy's Proposition 68 funds will be used to fund projects in the Conservancy's Community and Economic Enhancement Grant Program to support community and economic development in the Delta in a manner that is complementary to ecosystem restoration and other Conservancy programs. The grant program began accepting concept proposals on January 6, 2020.

Program and Policy Subcommittee Update September 16, 2020

In attendance were Vice Chair Leo Winternitz; Board Member Dolly Sandoval; Liaison Advisor Erik Vink; Deputy Attorney General Nicole Rinke, counsel to the Conservancy; Executive Officer Campbell Ingram; Deputy Executive Officer Debra Kustic; several Conservancy staff; and members of the public.

EASEMENTS AND LAND OWNERSHIP ASSESSMENT

The Executive Officer provided an overview of the Conservancy's authorities related to easements and land ownership, described the potential need to support sister agencies (CDFW and DWR) by holding ecosystem restoration project and levee maintenance mitigation project easements, and described current understanding of the requirements and processes to effectively manage easements. Vice Chair Winternitz suggested that staff identify one or more specific easement projects that can be used as real-world examples to explore resource requirements and processes.

Next Steps

Staff have identified two projects with two separate entities that will need easements in place within the next 12 to 24 months. The project proponents have agreed to support our learning effort. Staff will provide regular updates to the Program and Policy Subcommittee and the Board on this effort.
